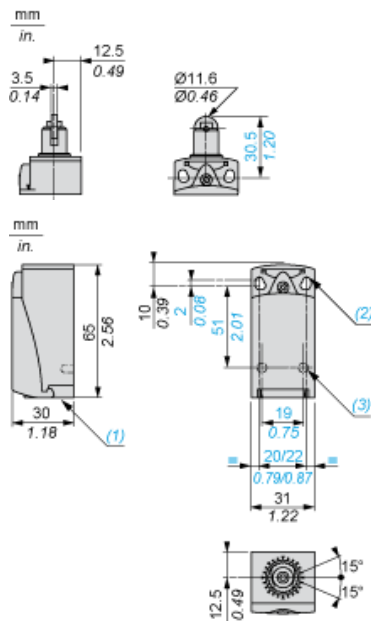

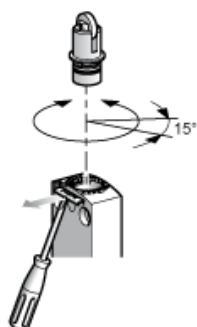

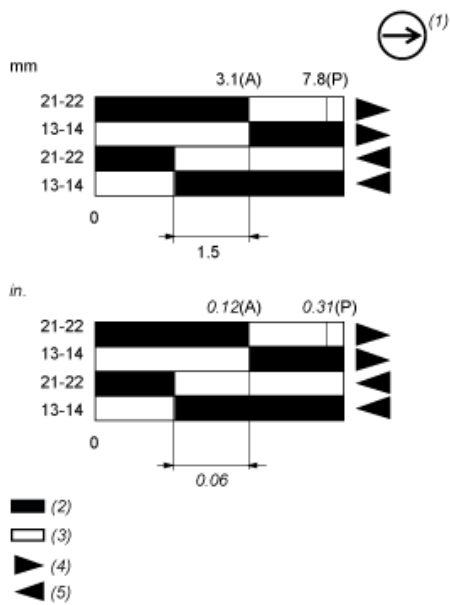


Characteristics of Actuation
